1. This Invitation for Tenders follows the General Procurement Notice (GPN) for this project that appeared in UNDB online: dated 30th November 2017 and on the African Development Bank Group's Internet Website.

The United Republic of Tanzania has received Financing from the African Development Bank in various currencies towards the cost of Institutional Support Project for Domestic Resources Mobilization and Natural Resources Governance (ISP-DRM & NRG), and it intends to apply part of the proceeds of this loan to cover eligible payments under the contract for Supply and Installation of Electrical, Power Backup Generator, Security and Equipment for Data Room Lot 1, 2, 3 and 4.
3. The Tanzania Petroleum Development Corporation (TPDC) on behalf of Petroleum Upstream Regulatory Authority (PURA), now invites sealed bids from eligible bidders for the Supply and Installation of Electrical, Power Backup Generator, Security and Equipment for Data Room Lot 1, 2, 3 and 4 as specified below;

2.	Supply and Installation of Security and Equipment for Data Room.
3.	Supply of Furniture for data Room
4.	Supply of Magnetic Seismic Tapes and Fire Proof Cabinet

Bidder can either bid in all lots or specific lot.

4. Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Regulations, 2013 – Government Notice No. 446 as amended in 2016, and is open to all Tenderers as defined in the Regulations.
