**ENVIRONMENTAL AND SOCIAL IMPACT ASSESSMENT (ESIA) ON THE
PROPOSED 2D SEISMIC DATA ACQUISITION FOR THE EYASI - WEMBERE
PROJECT IN TABORA (IGUNGA), SHINYANGA (KISHAPU), SINGIDA (IRAMBA)
AND SIMIYU (MEATU)**

TPDC is planning to conduct an Oil and Gas exploration in Eyasi Wembere Block through the 2D Seismic Survey so as to be able to map accurately the potential structural and stratigraphic traps and identify any existence of hydrocarbon prospects. Eyasi-Wembere Block is located in the northern part of Tanzania along the eastern branch of the great East African Rift System. The Block covers approximately 10,640 km² and composed of Eyasi, Wembere and Manonga sub-basins.

In compliance with the Environmental Management Act Cap 191 (No 20 of 2004) and the subsequent EIA and Audit Regulation of 2005 and its amendment of 2018, TPDC would like to inform the general public that, MTL Consulting Limited in partnership with Energy Intel Limited have been commissioned on its behalf to undertake Environmental Impact Assessment (EIA) for 2D Seismic data acquisition for the Eyasi – Wembere Project. The EIA study will cover four administrative regions covered by the block namely Tabora (Igunga), Shinyanga (Kishapu), Singida (Iramba) and Simiyu (Meatu).
