It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Supply and Installation of Indoor Fitness Equipment at Songosongo Gas Processing Plant - Songosongo Island.**
3. The Tanzania Petroleum Development Corporation now invites sealed tenders from eligible Suppliers for **Supplying and Installation of Indoor Fitness Equipment at Songosongo Gas Processing Plant - Songosongo Island.**
4. Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Regulations, 2013 - Government Notice No. 446 as amended in 2016, and is open to all Tenderers as defined in the Regulations.
