1. This Request for Expression of Interest follows the General Procurement Notice for this project which was published in the UN Development Business (UNDB online): dated 30<sup>th</sup> November 2017 and on the African Development Bank Group's Internet Website;

The Government of United Republic of Tanzania has received financing from the African Development Bank toward the cost of the Institutional Support Project for Domestic Resource Mobilization and Natural Resource Governance (ISP-DRM-NRG), and intends to apply part of the agreed amount for this loan to payments under the contract for Consultancy Service for Liquefied Natural Gas (LNG) Transaction Advisor for the Government Negotiation Team (GNT).
3. The objective of the assignment includes services but not limited to the following;
  - i. To develop a workable commercial, legal and technical framework/terms for the LNG project;
  - ii. To build capacity and facilitate the GNT team, and

iii. To devise the best approach to undertake negotiations of the Host Government Agreement (HGA).

The duration for the implementation of this assignment is two (2) years.

Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.).
